Course Overview

The Climate Finance & Green Investment Training Course provides a comprehensive and practical framework for understanding how financial resources can be mobilized, structured, and allocated to support climate action, sustainable infrastructure, and environmentally responsible economic development. Through practical exercises, investment cases, project assessments, and structured workshops, participants will develop the ability to assess climate finance opportunities, evaluate green investment proposals, compare financing structures, identify appropriate sources of capital, and develop practical frameworks for sustainable investment decisions. The course is designed to connect financial analysis with climate objectives without compromising the importance of commercial discipline and risk management.

Objectives

- Analyze the relationship between climate change, climate finance, green investment, and sustainable economic development during the course.
- Evaluate the financial, environmental, and strategic implications of climate-related investment opportunities.
- Assess the main principles and mechanisms of climate finance and their application to different project types.

- Design a preliminary financing structure for a climate adaptation, mitigation, renewable energy, infrastructure, or environmental project.
- Evaluate environmental and climate impact considerations alongside financial investment criteria.
- Develop practical approaches for measuring climate investment performance, environmental outcomes, and financial results.
- Prepare an actionable climate finance and green investment framework aligned with organizational priorities by the end of the course.

Who Should Attend

This training course is designed for professionals working in ministries and government entities responsible for finance, investment, economic development, planning, infrastructure, energy, environment, public investment, and sustainable development. It is particularly relevant to policymakers, public finance professionals, investment specialists, project finance professionals, development planners, sustainability specialists, climate policy professionals, and professionals responsible for evaluating or financing strategic development projects.

The course is also suitable for executives, senior managers, and specialists within banks, financial institutions, investment companies, asset management organizations, development finance institutions, energy companies, infrastructure operators, and large corporations. It is particularly valuable for professionals responsible for sustainable finance, corporate finance, project development, investment analysis, risk management, environmental strategy, capital planning, and climate-related investment programs.

Professionals involved in green investment, climate finance, project appraisal, infrastructure financing, public-private partnerships, investment portfolio management, treasury, sustainability, and strategic planning will benefit from the practical focus of the program.
