## Course Overview

---

The Contract Risk Management & Dispute Resolution Training Course provides a strategic and practical framework for identifying, assessing, managing, and mitigating risks throughout the contract lifecycle, while strengthening organizational capabilities in contractual dispute prevention and resolution. The course focuses on protecting commercial interests, improving contractual governance, reducing exposure to avoidable risks, and supporting successful project and operational outcomes.

Contracts across construction, infrastructure, energy, oil and gas, government procurement, engineering, and major services involve complex commercial, technical, financial, legal, and operational risks. Unclear obligations, inadequate documentation, scope changes, delays, payment issues, performance failures, and ineffective communication can create significant contractual exposure. This course equips participants with structured methods for identifying these risks early and establishing appropriate controls.

The program covers contract risk identification, risk assessment, allocation, mitigation, monitoring, and reporting, with particular emphasis on risks related to scope, schedule, cost, performance, payment, variations, claims, compliance, suppliers, contractors, and external events. Participants will learn how to establish contract risk registers, assess risk ownership, develop mitigation measures, and integrate contractual risks into project and organizational risk management processes.

A major focus is placed on dispute prevention and resolution. Participants will examine the causes and stages of contractual disputes and explore practical approaches to early intervention, negotiation, mediation, adjudication, arbitration, and other appropriate resolution mechanisms. The course emphasizes the importance of contractual records, notices, correspondence, evidence, communication, and structured issue management in preventing disputes and supporting an organization's contractual position.

Through case studies, risk assessment exercises, dispute scenarios, negotiation simulations, and practical workshops, participants will develop the ability to establish effective contract risk management systems and apply appropriate dispute resolution strategies. The course supports government entities, ministries, public-sector organizations, oil and gas companies, energy organizations, infrastructure operators, contractors, consultants, and large corporations seeking stronger contractual control and reduced commercial exposure.

## Objectives

---

- Analyze the principles of contract risk management and their role throughout the contract lifecycle.
- Identify contractual, commercial, technical, financial, operational, and legal risks affecting contract performance.
- Assess the probability, impact, ownership, and priority of major contractual risks.
- Develop structured contract risk registers covering key risks, controls, owners, and mitigation actions.
- Apply appropriate risk allocation principles when establishing contractual responsibilities and obligations.
- Develop mitigation and contingency measures for significant contract risks.
- Evaluate risks associated with scope changes, delays, payments, variations, claims, performance failures, and compliance.
- Strengthen contractual documentation, notices, correspondence, and evidence management to support risk control.
- Analyze the causes, escalation patterns, and potential consequences of contractual disputes.
- Apply negotiation, mediation, adjudication, arbitration, and other dispute resolution approaches appropriately.
- Develop early-warning and issue-management mechanisms to prevent contractual disputes from escalating.
- Design an integrated Contract Risk Management & Dispute Resolution framework by the end of the course.

## Who Should Attend

---

This training course is designed for Contract Managers, Contract Administrators, Commercial Managers, Project Managers, Procurement Managers, Claims Managers, Project Directors, Legal and Commercial Professionals, Quantity Surveyors, Project Controls Professionals, Engineers, and specialists responsible for contractual risk and dispute management.

The course is particularly relevant to professionals working in ministries, government entities, public-sector organizations, construction and infrastructure companies, oil and gas organizations, energy companies, utilities, engineering firms, contractors, consultants, and large corporations. It is also valuable for professionals in legal, procurement, finance, project management, risk management, commercial, and project controls departments.

The program will benefit executives, senior managers, department heads, commercial decision makers, contract leaders, project directors, and professionals involved in approving contractual strategies, allocating risks, managing claims, negotiating settlements, or resolving disputes. It provides an integrated approach connecting contract risk management with commercial governance, project performance, and dispute prevention.

- Identify the causes and escalation stages of contractual disputes.

- Select appropriate dispute prevention and resolution mechanisms based on the nature and circumstances of the dispute.
- Apply negotiation and settlement techniques to support commercially appropriate dispute outcomes.
- Develop an integrated framework for contract risk management and dispute resolution within an organization.
