## Course Overview

---

The ESG Investing & Sustainable Finance Training Course provides a comprehensive professional framework for understanding how environmental, social, and governance considerations are integrated into investment decisions, financial strategy, risk management, and long-term organizational value creation. Through practical exercises, case discussions, investment analysis activities, and implementation workshops, participants will develop the ability to translate ESG principles into actionable financial and investment decisions. The course supports organizations seeking to strengthen sustainable investment capabilities, improve risk awareness, enhance governance, and align financial strategies

with evolving sustainability expectations and long-term organizational objectives.

## Objectives

---

- Analyze the core principles of ESG investing and sustainable finance and explain their relevance to modern investment and financial decision-making by the end of the first day.
- Evaluate environmental, social, and governance factors and determine their potential relevance to investment risk, return, valuation, and long-term business performance during practical case exercises.
- Apply ESG integration techniques to investment analysis and assess how sustainability-related information can influence investment decisions by the end of the course.
- Develop an ESG-focused investment assessment framework that incorporates material sustainability factors, financial considerations, risk indicators, and organizational objectives.
- Assess climate-related and broader sustainability risks and evaluate their potential impact on corporate financial performance, portfolios, financing decisions, and institutional risk exposure.
- Design practical approaches for integrating ESG considerations into portfolio management, investment policies, asset allocation, and financial decision-making within an organizational context.
- Evaluate sustainable finance instruments, including green bonds, social bonds, sustainability-linked bonds, and other sustainability-oriented financing mechanisms, based on their purpose, structure, risks, and suitability.
- Strengthen the ability to assess ESG data, ratings, disclosures, and performance indicators while identifying limitations, inconsistencies, and potential greenwashing risks.
- Develop practical recommendations for improving ESG governance, investment processes, stakeholder accountability, and sustainability-related financial decision-making.
- Align ESG investing and sustainable finance practices with organizational strategy, risk management priorities, governance requirements, and long-term value creation objectives by completing a final implementation exercise.

## Who Should Attend

---

This ESG Investing & Sustainable Finance Training Course is designed for investment professionals, portfolio managers, asset managers, financial analysts, corporate finance professionals, treasury specialists, risk managers, and professionals involved in investment research, financial planning, capital allocation, or sustainable investment activities. It is also highly

relevant to professionals working in banking, private banking, wealth management, insurance, pension funds, sovereign and institutional investment environments, and financial services organizations.

The course is suitable for executives, senior managers, investment committee members, finance directors, chief financial officers, risk and compliance managers, sustainability and ESG professionals, corporate strategy teams, governance specialists, and decision makers responsible for financial strategy and organizational performance.
