## Course Overview

---

The Evidence-Based Policy Making Training Course provides a practical and strategic framework for developing, assessing, and improving public policies through reliable evidence, structured analysis, and transparent decision-making. The program is designed for government institutions, ministries, public-sector organizations, and policy professionals seeking to strengthen the quality, relevance, and effectiveness of policies and government interventions.

Effective public policy requires more than identifying problems and proposing solutions. Policymakers need to understand the underlying causes of policy challenges, assess available evidence, compare alternative interventions, evaluate potential impacts, and make informed decisions within real-world constraints. Evidence-based policy making provides a systematic approach for connecting data, research, stakeholder insights, institutional knowledge, and policy priorities with practical government decisions.

The course covers the policy development cycle, including problem definition, evidence identification, data and research assessment, stakeholder analysis, policy option development, impact assessment, cost and benefit considerations, implementation planning, monitoring, evaluation, and policy review. Participants will learn how to distinguish reliable evidence from assumptions and opinions and how to translate analytical findings into clear policy recommendations.

Particular emphasis is placed on applying evidence to complex government decisions. Participants will explore qualitative and quantitative evidence, policy research, administrative data, performance information, comparative analysis, scenario analysis, stakeholder consultation, and evaluation findings. The program also addresses common challenges such as incomplete evidence, conflicting findings, uncertainty, data limitations, political and operational constraints, and competing stakeholder interests.

Through practical case studies, policy analysis exercises, evidence assessment, stakeholder mapping, policy option comparison, impact analysis, and policy recommendation workshops, participants will develop practical capabilities to produce stronger policy analysis, communicate evidence effectively, support accountable decision-making, and improve the effectiveness and sustainability of public policies.

## Objectives

---

- Analyze the principles and foundations of evidence-based policy making in the public sector.
- Define policy problems clearly using structured problem analysis and available evidence.
- Identify, assess, and organize relevant quantitative and qualitative evidence for policy decisions.
- Evaluate the credibility, relevance, limitations, and applicability of different evidence sources.
- Apply analytical techniques to understand policy problems, causes, impacts, and stakeholder interests.
- Develop and compare alternative policy options against defined criteria and government priorities.
- Assess the potential economic, social, operational, regulatory, and institutional impacts of policy options.
- Apply structured approaches to stakeholder analysis and evidence-informed consultation.
- Develop evidence-based policy recommendations that clearly connect findings with proposed actions.
- Design monitoring and evaluation approaches for assessing policy implementation and outcomes.
- Communicate complex evidence and analytical findings clearly to executives, policymakers, and decision makers.
- Develop a practical framework for integrating evidence into the policy development and review cycle.

## Who Should Attend

---

This training course is designed for government executives, policy directors, senior managers, policy analysts, strategic planning professionals, researchers, and public-sector officials involved in policy development, analysis, implementation, monitoring, or evaluation.

It is particularly relevant to ministries, government authorities, regulatory bodies, public agencies, municipalities, and public-sector organizations responsible for developing policies, strategies, regulations, programs, and public interventions. The course is also valuable for professionals seeking to strengthen the analytical foundations supporting government decisions and public-sector reforms.

The program will benefit policy advisors, economists, data and research specialists, performance professionals, program managers, regulatory professionals, monitoring and evaluation specialists, governance professionals, public administration specialists, and senior decision makers who need to interpret evidence, assess policy alternatives, and translate analytical findings into practical recommendations.
