Course Overview

A strong emphasis is placed on KPI optimization and the development of practical facilities dashboards and reporting structures. Participants will learn how to evaluate existing indicators, eliminate duplication, improve data quality, establish realistic targets, and create management reports that provide clear visibility into facility performance. The course also addresses benchmarking, service-level performance, maintenance KPIs, asset performance, energy indicators,

financial measures, and customer or occupant experience.

Through case studies, practical exercises, performance analysis activities, and workshop-based applications, participants will develop the ability to build a comprehensive facilities performance framework and optimize KPIs according to organizational requirements. The Facilities Performance Management & KPI Optimization Training Course supports government entities, public-sector organizations, banks, corporations, industrial facilities, oil and gas organizations, infrastructure operators, and other institutions seeking measurable improvements in facilities efficiency, service delivery, asset performance, and operational control.

- Design an integrated Facilities Performance Management and KPI Optimization framework by the end of the course.
