## Course Overview

---

The Government Resilience & Disaster Recovery Training Course provides a strategic and practical framework for enabling ministries, government entities, and public-sector organizations to prepare for, respond to, and recover from disasters, crises, disruptions, and operational interruptions while maintaining critical government services. The course focuses on developing organizational resilience, strengthening preparedness, and establishing practical capabilities that enable government institutions to protect essential functions and recover effectively.

Government resilience requires more than emergency response. It involves the ability to anticipate threats, understand organizational vulnerabilities, prepare for disruption, respond effectively under pressure, and restore critical operations within appropriate timeframes. Effective resilience therefore integrates risk management, business continuity, disaster recovery, crisis management, technology resilience, workforce readiness, facilities, supply chains, communications, and stakeholder coordination.

The program covers the essential principles of government resilience and disaster recovery, including risk and threat identification, business impact analysis, critical service identification, dependency analysis, continuity strategies, disaster recovery planning, crisis response, emergency coordination, communications, resource management, technology recovery, and organizational preparedness.

Particular emphasis is placed on developing practical and actionable resilience plans rather than relying solely on theoretical documentation. Participants will learn how to establish recovery priorities, identify alternative resources and operating arrangements, develop crisis leadership structures, manage disruption scenarios, coordinate response activities, test plans through simulations, and use lessons learned to strengthen organizational readiness.

Through case studies, risk assessment exercises, business impact analysis, crisis simulations, continuity planning, disaster recovery exercises, and implementation workshops, participants will develop the practical capabilities required to strengthen government resilience, reduce the impact of disruptions, accelerate recovery of critical services, and support the continuity of essential government operations.

## Objectives

- Analyze the fundamental principles of government resilience, business continuity, and disaster recovery.
- Assess risks and threats that could affect critical government services, operations, and resources.
- Identify and prioritize critical government functions, services, processes, and dependencies.
- Apply Business Impact Analysis techniques to assess the consequences of operational disruptions.
- Develop appropriate continuity and recovery strategies for different disruption scenarios.
- Design practical Business Continuity and Disaster Recovery Plans aligned with organizational priorities.
- Develop clear crisis leadership structures, roles, responsibilities, and escalation mechanisms.
- Apply crisis management and internal and external communication practices during emergencies.
- Assess the readiness of people, facilities, technology, data, suppliers, and critical resources.
- Design exercises, simulations, and testing programs to validate continuity and recovery capabilities.
- Analyze incident and exercise results to identify preparedness gaps and corrective actions.
- Develop a practical roadmap for strengthening government resilience and sustaining critical services.

## Who Should Attend

---

This training course is designed for government executives, senior public-sector leaders, risk managers, business continuity managers, disaster recovery professionals, crisis management managers, emergency management professionals, and operations leaders responsible for organizational resilience and critical service continuity.

It is particularly relevant to ministries, government authorities, municipalities, and public-sector organizations responsible for delivering essential services or managing critical operations that may be affected by natural disasters, technological failures, cyber incidents, infrastructure disruptions, supply chain interruptions, or other crisis scenarios.

The program will also benefit business continuity specialists, risk professionals, IT disaster recovery teams, information security professionals, emergency and safety managers, facilities managers, supply chain professionals, project and program managers, communications teams, governance professionals, and decision makers responsible for protecting critical government services and organizational capabilities.
