## Course Overview

---

The Green Procurement & Environmental Sustainability Training Course provides a practical and strategic framework for integrating environmental sustainability into procurement policies, sourcing decisions, supplier evaluation, contracting, and purchasing operations. Through practical exercises, procurement scenarios, supplier assessments, lifecycle analysis, specification development, and performance measurement activities, participants will develop the skills required to design and implement effective green procurement practices aligned with organizational sustainability objectives.

- Identify environmental risks within procurement and supply networks.
- Improve transparency and documentation of green procurement decisions.
- Develop a practical roadmap for implementing and continuously improving green procurement.
