Course Overview

The Identity Governance & Administration (IGA) Training Course provides a comprehensive and practical framework for governing digital identities, managing access rights, and establishing effective identity administration across modern enterprise environments. The course focuses on ensuring that users receive appropriate access based on their roles and responsibilities while maintaining strong security, regulatory compliance, operational efficiency, and accountability.

- Develop a practical roadmap for implementing and continuously improving IGA capabilities.

It is also suitable for risk and compliance professionals, internal auditors, governance specialists, enterprise architects, security operations teams, human resources and IT process owners, and managers responsible for access approvals, user lifecycle processes, segregation of duties, or regulatory compliance.
