## Course Overview

---

Oil & Gas Facilities Management Training Course is a specialized professional program designed to develop the capabilities required to manage, operate, maintain, and continuously improve facilities across the oil and gas industry. The course provides an integrated understanding of facilities management within complex operational environments, with emphasis on asset performance, reliability, maintenance, safety, operational efficiency, cost control, service quality, and business continuity.

Oil and gas facilities depend on the coordinated performance of buildings, production support systems, utilities, infrastructure, equipment, maintenance services, contractors, and technical resources. Effective facilities management therefore requires more than routine maintenance or property administration. It requires structured planning, risk-based decision-making, lifecycle thinking, performance monitoring, resource optimization, and close coordination between facilities, operations, engineering, maintenance, HSE, procurement, and management teams.

This Oil & Gas Facilities Management Training Course examines the full facilities management lifecycle, from strategic planning and facility requirements through operations, maintenance, asset management, energy management, contractor management, emergency preparedness, and performance improvement. Participants will explore practical approaches for managing critical facilities while maintaining operational reliability, safety, regulatory compliance, service continuity, and cost effectiveness.

The course also addresses the specific challenges of facilities operating in oil and gas environments, including remote sites, production support facilities, processing plants, terminals, storage areas, workshops, warehouses, administrative buildings, accommodation facilities, utilities, and other infrastructure. Participants will learn how to establish effective facilities management systems that support operational priorities and organizational objectives.

Through practical exercises, case-based discussions, performance analysis, and workplace-oriented applications, participants will develop the ability to assess facility performance, prioritize maintenance and improvement activities, manage service providers, monitor key performance indicators, optimize resources, and establish continuous improvement initiatives. The course is

suitable for organizations seeking to strengthen the strategic and operational contribution of facilities management to overall business performance.

## Objectives

---

- Analyze the principles, functions, and strategic role of facilities management within oil and gas organizations and complex operational environments.
- Develop structured facilities management strategies aligned with organizational objectives, operational requirements, asset priorities, and service expectations.
- Evaluate the condition, criticality, performance, and lifecycle requirements of facilities, infrastructure, utilities, and supporting assets.
- Apply effective facilities planning and maintenance management practices to improve reliability, availability, safety, and service continuity.
- Design practical approaches for managing facility operations, technical services, support services, and workplace infrastructure.
- Improve facilities performance through appropriate KPIs, service-level measures, inspections, audits, and performance reviews.
- Assess energy, utilities, resource consumption, and operational efficiency opportunities within oil and gas facilities.
- Strengthen contractor and service-provider management through effective scope definition, performance requirements, monitoring, and evaluation.
- Implement risk-based approaches to facility maintenance, operational continuity, emergency preparedness, and critical service management.
- Align facilities management with asset management, HSE, procurement, business continuity, sustainability, and organizational risk management.
- Develop practical cost-control and lifecycle management approaches that support informed facilities investment and operational decisions.
- Establish a continuous improvement framework for enhancing facilities performance, service quality, reliability, and organizational value.

## Who Should Attend

---

This course is designed for Facilities Managers, Facilities Directors, Facility Engineers, Operations Managers, Maintenance Managers, Engineering Managers, Asset Managers, Property and Infrastructure Managers, Technical Services Managers, and professionals responsible for the operation and performance of oil and gas facilities. It is also relevant to professionals responsible for utilities, buildings, infrastructure, accommodation, workshops, warehouses, site services, and other facility-related functions.

The program is particularly suitable for maintenance engineers, reliability professionals, HSE specialists, procurement and contract managers, project managers, energy and utilities professionals, workplace services teams, operations supervisors, and technical support personnel who interact with facilities management functions. Professionals working in production facilities, processing plants, refineries, gas plants, terminals, storage facilities, offshore installations, onshore sites, and corporate support facilities can apply the concepts directly to their operational environments.

Executives, department heads, senior managers, and decision makers involved in facilities strategy, capital planning, operational expenditure, asset performance, service delivery, risk management, and business continuity will also benefit from the course. The program provides a management-level perspective while maintaining sufficient technical and practical depth for specialists and operational professionals.

- Integrate facilities management with asset management, HSE, risk management, procurement, emergency preparedness, and business continuity.
- Assess facility risks and develop appropriate mitigation, contingency, and continuity measures for critical services.
- Improve lifecycle planning and decision-making for facility assets, infrastructure, systems, and supporting services.
- Prepare a practical facilities management improvement plan aligned with organizational priorities and operational requirements.
