## Course Overview

---

The Sustainable Public Health Management Training Course is a practical and strategically focused program designed to strengthen the capabilities required to plan, manage, evaluate, and continuously improve sustainable public health programs. Participants will explore how sustainable health practices can be integrated into organizational policies, risk management systems, environmental health programs, and operational planning.

The course emphasizes practical application through case studies, workplace scenarios, data analysis exercises, emergency simulations, and strategic planning workshops. Participants will develop the ability to translate health data and risk assessments into practical programs, measurable performance indicators, effective prevention strategies, and sustainable improvement initiatives that support organizational resilience and informed decision-making.

## Objectives

- Analyze the principles of sustainable public health management and their relationship with long-term organizational and community health outcomes.
- Assess workforce and population health needs and establish priorities based on evidence, risk exposure, available resources, and organizational objectives.
- Apply structured methodologies to identify, evaluate, and prioritize public health, occupational health, and environmental health risks.
- Develop sustainable public health and health promotion programs aligned with organizational needs and strategic priorities.
- Evaluate the social, environmental, occupational, and economic factors that influence health outcomes and determine appropriate intervention priorities.
- Design measurable performance indicators for monitoring the effectiveness, efficiency, quality, and sustainability of public health programs.
- Analyze health and environmental data to identify trends, emerging risks, performance gaps, and opportunities for preventive action.
- Develop practical strategies for disease prevention, health promotion, early detection, health surveillance, and risk reduction.
- Strengthen integration between public health, occupational health, environmental health, sustainability, emergency preparedness, and enterprise risk management.
- Evaluate the effectiveness and impact of public health interventions and identify appropriate corrective and improvement actions.
- Design effective coordination and stakeholder engagement approaches involving government agencies, healthcare organizations, operational departments, and communities.
- Develop an actionable sustainable public health management plan incorporating priorities, resources, responsibilities, performance indicators, implementation stages, and continuous improvement mechanisms.

## Who Should Attend

This course is designed for Public Health Managers, Public Health Specialists, Environmental Health Specialists, Occupational Health Managers, Occupational Health Professionals, Health Promotion Specialists, Health Program Managers, Health Policy and Planning Specialists, Public Health Officers, Health Surveillance Professionals, Health Risk Management Specialists, and professionals responsible for designing, implementing, monitoring, and evaluating public health initiatives.

It is also highly relevant to executives, department heads, decision makers, facility managers, Human Resources leaders, Health, Safety and Environment professionals, Sustainability Managers, Risk Managers, Emergency Preparedness Managers, and Corporate Health professionals within ministries, government authorities, public sector organizations, healthcare institutions, industrial companies, energy organizations, and oil and gas companies. The program is particularly suitable for professionals responsible for workforce health, community health protection, environmental health, emergency preparedness, health risk management, and sustainable organizational performance.
